Effective March 23, 2024, the government has replaced the Genuine Temporary Entrant (GTE) requirement for student visas with a [Genuine Student \(GS\) requirement](#). This change applies to student visa applications submitted on or after this date. All applicants must demonstrate genuine intent to enter Australia as a student and understand that studying in Australia is the primary purpose of their visa. To qualify for a student visa, applicants must satisfy the genuine student criterion or genuine student dependent criterion. International students applying to ATI must genuinely intend to study, adhere to visa requirements, successfully complete their ATI course, and enroll in their ATI qualifications.
